## DIRECTIONS TO RED LION HOTEL AND CONFERENCE CENTER - PASCO

### From I-5/Highway 18/I-90 East:

- Take Exit 142A off of I-5 and merge onto Highway 18 East toward Auburn
- Follow Highway 18 and merge onto I-90 East via the ramp to Spokane
- Take Exit 137 off of I-90 and merge onto Highway 26 East toward Othello/Pullman
- Turn right onto Highway-243 South
- At the traffic circle, take the 2<sup>nd</sup> exit and stay on Highway-243 South
- Continue onto Highway 24 West
- Continue onto Highway 240 East
- Use the right two lanes to turn right onto Highway 240 East
- Merge onto I-182 East
- Use the middle lane to take exit 12A for US-395 South toward Kennewick/Pendleton
- Keep left at the fork to continue on Exit 12B and follow the signs for North 20<sup>th</sup> Avenue/Columbia Basin College
- Use the left two lanes to turn left onto North 20<sup>th</sup> Avenue
- Turn right, then left and the hotel is on the right
